ORDER U/S.12AA(1)(b)(i) OF THE INCOME TAX ACT,1961:

1. The above trust registered as a society under Societies Registration Act,1860 on 03.05.2013 has filed an application in Form No.10A for Registration U/s.12A(1)(aa) of the Income Tax Act,1961 on 05.12.2014. After filing the application, the applicant has made certain amendment to its Memorandum, registered on 25.06.2015.
2. Accordingly, the said society is hereby registered and assigned URN: AACAK3168Q/07/14-15/S-0333 in the register maintained in this office. This registration is granted with effect from 25.06.2015.
3. The registration does not ipso facto exempt the income unless the provisions of Section 11,12 and 13 of the I.T.Act,1961 are adhered to.
4. The applicant shall comply with the provisions of Section 139(4A).
5. No amendment in the Memorandum of Association shall be effected without the prior approval of the Commissioner of Income Tax(Exemptions), Hyderabad.
6. In the event of dissolution of the society, the net assets of the society, after meeting all liabilities, will be transferred to any society or institution having similar objects and which is registered u/s.12AA of the Act and as approved by the Commissioner of Income Tax(Exemptions), Hyderabad.
7. This society is henceforth assessable by the Income Tax Officer(Exemptions), Ward Bhubaneswar.
8. In terms Section 12AA(3), if the activities of the society are found to be not genuine or not being carried out in accordance with the objects of the society, the registration granted vide this order shall be liable for cancellation.
